As part of his solid tax disputes and litigation practice, Mr. Muñiz has represented clients at all levels and in every type of tax disputes against all Puerto Rico Taxing Authorities. Some of his recent engagements include:

- Member of the legal team that successfully represented the taxpayer in a \$14MM municipal license tax dispute on the scope of the exemption applicable to export sales made from a Foreign Trade Zone and the lack of authority of the municipality to impose requirements to claim an exemption in addition to those provided for in the statute. See *Lilly del Caribe, Inc. v. Municipio de Carolina*, 2022 TSPR 101 (August 2, 2022).
- Successful representation of various taxpayers during administrative and judicial challenge of personal property tax deficiencies, assessed through the jeopardy assessment procedure, for approximately \$3.6 million. See, *Janssen Ortho LLC, et als. v. Centro de Recaudación de Ingresos Municipales*, KLAN 2018-00144 (Op. May 21, 2018), confirming trial court's judgment ordering the total cancellation of the alleged deficiencies and outlining adequate notification requirements for jeopardy assessment procedures.
- Leading role in real property tax litigations for clients in the manufacture and pharmaceutical industries obtaining significant tax savings through successful settlement negotiations. See *Lifescan Products LLC v. Centro de Recaudación de Ingresos Municipales*, 193 DPR 591 (2015).
- Actively participated in numerous cases representing multiple clients challenging the Special Property Tax imposed by Act No. 7 of March 9, 2000. See *Pfizer Pharmaceuticals LLC v. Secretario de Hacienda*, 2011 TA 1019 (March 31, 2011);
