Mary Massaron, a partner of Plunkett Cooney, one of the Midwest's oldest and largest law firms, was recently installed as President of the DRI – The Voice of the Defense Bar (DRI).

Massaron, who currently serves as Plunkett Cooney's Appellate Law Practice Group Leader and a member of the firm's Board of Directors, became President of DRI for a one-year term during the DRI annual meeting on Oct. 24-28 in New Orleans, Louisiana.
