The U.S. News – Best Lawyers® "Best Law Firms" rankings are based on a rigorous evaluation process that includes the collection of client and lawyer evaluations, peer review from leading attorneys in their field, and review of additional information provided by law firms as part of the formal submission process. To be eligible for a ranking, a law firm must have at least one lawyer listed in 20th Edition of *The Best Lawyers in America®* list for that particular location and specialty. Over 17,000 attorneys provided approximately 600,000 law firm assessments, and nearly 7,500 clients provided more than 40,000 evaluations.

Awards were given to law firms across the country in 74 national practice areas. Rankings were also conducted by metropolitan and state segments in 120 practice areas.
