

### Sheppard Mullin Capital Markets Team Advises on 14 Transactions in 2 Weeks, Raising More than \$695 Million in Gross Proceeds

#### Transactions Ranged from PIPE Financings, Follow-On Public Offerings to IPOs

Sheppard Mullin's Capital Markets team acted as counsel on 14 transactions raising more than \$695 million in gross proceeds, all of which closed between February 5-17, 2021.
