She also defends attorneys facing ethics complaints before the Board of Professional Conduct and was named as special disciplinary counsel.

### Career highlights include:

The Supreme Court of Ohio's opinion in the matter quoted five paragraphs of Rosemary's closing argument and has been cited as authority more than a dozen times.
