Experience

Our work spans the nation, having consulted on incentive deals in more than 30 states, for organizations of all sizes. Additionally, we offer strong experience in Ohio workers' compensation, the Occupational Safety and Health Act (OSHA), the Americans with Disabilities Act (ADA), the Family and Medical Leave Act (FMLA) and all claims against employers related to the health and safety of employees. Our experience with agriculture includes:

- Drafting an Amicus Brief for the Ohio Farm Bureau in support of farmers' rights and against punitive state eminent domain laws. This brief, submitted for *Knick v. Township of Scott, Pa.*, was the first time in its nearly 100 year history that the organization participated in a case before the Supreme Court of the United States.
- Representing family farm in bringing constitutional rights claims against Toledo for adopting the Lake Erie Bill of Rights and successfully obtaining an order invalidating Lake Erie Bill of Rights as violating the Due Process Clause of the United States Constitution.
- Representing property owners with apple orchard and Class III wetlands in sale of property to conservation group through Clean Ohio acquisition grant process.
- Advising large grain farmer on seven figure crop insurance claim.
- Representing an agribusiness in connection with its site selection and development of a 600-acre processing facility. We've provided consultation and strategy relative to the site selection process; preparation of option agreements for multiple parcels of land with contingency for simultaneous options and closings, together with all supplementary activities relating to site selection, land acquisition and development; acquisition of options for properties comprising sites and coordination of

all such options; preparation of system for evaluation and analysis of each site, including the creation of reference binders for each site relating to location, acreage, site-specific information, transportation, labor force, strategy relative to geographical aspects, local community facts and profiles; and participation in various site visits and negotiations with property owners, representatives of local political subdivisions, community improvement corporations, and port authority.

- Representing a farmer in an eminent domain case. The Ohio Department of Natural Resources offered our client only \$220,000. We took the matter to a jury trial and won nearly six times what was originally offered.
- Representing a client whose farm was bisected by a limited-access highway constructed by ODOT. Our team brought the issue to jury and awarded our client more than \$625,000 above the State's "good faith" offer.
- Representing a client whose corner frontage of their farm was taken in a Franklin County road-realignment project. Vorys was able to negotiate a settlement on behalf of our client for more than \$800,000 above Franklin County's initial offer.
