Lawyers must have a minimum of fifteen years trial experience before they can be considered for fellowship.

Membership in the College cannot exceed one percent of the total lawyer population of any state or province. Herlihy has a varied litigation practice and extensive trial experience, with a focus on commercial litigation. Recently, Herlihy has

focused her practice on litigating antitrust, intellectual property, franchise and insurance coverage issues facing the firm's business clients.
